


### Q: Which is the legal system in Nigeria?

Kristosa Klagerfut Kudalump Lagos La A: Nigeria has a mixed legal system comprising English common law, Sharia and customary law. The 1999 Constitution is the supreme law of Nigeria, prevailing over all other sources of law. In fact, any laws that are inconsistent with the Constitution are void to the extent of the inconsistency. English common law, judicial precedents, predominantly from the Supreme Court, form a key part of the Nigerian legal system, even if certain rulings and legislation are not rigidly applied: customary law is often applied for members of ethnic groups particularly concerning personal and family matters.



# Q: And what about the muslim population, established in the Northern part of Nigeria? There are about 50% of entire population, aren't they...

Monthod Moselo Moseow Munich Munich Munich Najobs New Dah A: Yes, infact twelve Northern States have introduced Sharia legal system. Sharia used to be categorized as a customary law in Nigeria. This position has changed given the judicial pronouncement by the Supreme Court in the case of Alkamawa v Bello (1998) LPELR-SC.293/1991. The independence of the judiciary is guaranteed by Sections 4, 5 and 6 of the Constitution of the Federal Republic of Nigeria 1999 (as amended) ("The 1999 Constittion). The Nigerian court system consists of the Supreme Court, Court of Appeal, Federal High Court, High Court of the Federal Capital

The appointment of a person to the office of Chief Justice of Nigeria (CJN) is made by the President of the Federal Republic of Nigeria on the recommendation of the National Judicial Council subject to confirmation of such appointment by the Senate while appointment of a person to the office of a Justice of the Supreme Court is made by the President of the Federal Republic of Nigeria on the recommendation of the National Judicial Council subject to confirmation of such appointment by the Senate. To qualify to hold the office of CJN or a Justice of the Supreme Court, such a person must
















have been qualified to practice as a legal practitioner in Nigeria and has been so qualified for a period of not less than fifteen years.

The appointment of a person to the office of President of the Court of appeal is made by the President of the Federal Republic of Nigeria on the recommendation of the National Judicial Council subject to confirmation of such appointment by the Senate and appointment of a person to the office of a Justice of the Court of Appeal is made by the President on the recommendation of the National Judicial Council. To be appointed to hold the office of a Justice of the Court of Appeal, such a person must be qualified to practise as a legal practitioner in Nigeria and has been so qualified for a period of not less than twelve years.

For dispute resolution at international level, Nigeria is a member of the International Centre for Settlement of Investment Disputes, as well as a signatory to the 1958 New York Convention. More, very important is the Companies and Allied Matters Act 2020 (as amended) which regulates the registration, promotion and operation of companies in Nigeria and the Nigerian Investment Promotion Commission Act 2004, which permits foreign ownership in all industries except for those listed on the negative list.

### Q: You live in Lagos....

A: Yes, I live in Lagos, the commercial centre of West Africa. After obtaining a Bachelor Degree (LL.B) from the University of Benin, Benin City, Edo State, Nigeria, I also had a Master's Degree (LL.M) from the University of Lagos, where I presently live with my family. ### Q: I read that you and your firm also provide services in shipping and maritime law....


